



International Students Fee Schedule 2023

The following schedule of fees has been approved by the College Council, effective from the commencement of Term 1, 2023. The College reviews the fee schedule on an annual basis.

Enrolment Fee \$200 (non-refundable) This fee is required to be paid upon acceptance of enrolment.

Deposit \$3,000 This fee is payable upon acceptance of enrolment.

The deposit is refundable when the student completes their course and must be made by written application. Money will be refunded after the College is satisfied that all expenses incurred have been deducted.

The deposit is not refundable if a place is accepted but the student does not subsequently attend the College. If the student leaves without giving the required two (2) terms notice, the deposit will be refunded when the two term's fees in lieu are paid.

Table of Fees

The College Boarding and Tuition Fee is an annual fee, which, for the convenience of parents, is charged in four equal instalments. All amounts are in Australian Dollars (\$A).

Services \$600 per term

This is a compulsory charge per student for general services, improvements to facilities and technology.

New Students

Once an Application for Enrolment has been received by the College, applicants will usually be interviewed. Following a successful interview, an Offer of Enrolment will then be made. The enrolment will be finalised on receipt of the signed Offer of Enrolment along with the enrolment fee and a number of completed forms.

Family Concession

The College grants a tuition fee concession to siblings attending the College from Kindergarten to Year 12 simultaneously:

Eldest student in family	Full Fee
1st Sibling	10%
2nd Sibling	20%
3rd and subsequent Siblings	30%

Fee Statement

A fee statement is issued prior to the commencement of each school term and is due for payment on the first day of term. This account includes tuition and boarding, disbursements and services. A second fee statement is issued mid-term reflecting any further disbursements and outstanding balance from previous accounts. The College may refuse re-entry of a student if any fees are outstanding. An administration charge of 3% of the outstanding balance is applied to accounts not paid by the due date.

Payment of Fees in Advance

A \$50 discount is applicable to the fees if paid **before** the first day of term.

An allowance is available to those who wish to pay the full yearly fee by the first day of Term 1. Please contact the Accounts Team on 02 6331 3911 to take advantage of this offer.

Other Charges

Additional charges will apply for extra subjects taken, including Distance Education and TAFE fees, incursions, excursions and other incidentals.

- Uniforms are **not included** in the Tuition and Boarding Fee. Uniforms can be purchased at the College Uniform Shop located on the Junior School Campus and must be paid for in full at the time of fitting (approx. \$1,000). Eftpos facilities are available.

Enrolments After Commencement of a Term

When a student commences at the College after a term has commenced, enrolment will be accepted with payment of the Enrolment Fee and Deposit, with the term fee being charged at a pro rata rate. Pro rata fees are calculated as a proportion of the annual fee.

Notice of Withdrawal

Two (2) terms notice in writing or two terms fees are required in lieu of notice given for the withdrawal of a student, except in the graduating term for Higher School Certificate students. When a student is withdrawn after the commencement of a term, the College will refund the appropriate pro rata of the pre-paid fee, less any disbursement incurred, providing the required notice is given.
